**Sewer Project**-No activity. Brian said that he has been in contact with QA County Administator Todd Mohn. Our submitted application to the State for \$6,000,000 is 8<sup>th</sup> on the roster.

**DeMoss/Seaman Annexation Plan**. Tonite's hearing was postponed and rescheduled for the next Town meeting due to the fact that the county has not reviewed the plan yet. Hearing will be held September 18, 2019. Virginia will post an ad in the newspaper of the date change.

**Revised Ordinance 19-01**. A revised Ordinance 19-01 was submitted with grammatical corrections. A motion was made by Bill and seconded by Brian to approve the revised ordinance and reduce the Personal Property Tax rate to \$.20 per \$100 of inventory assessment. The motion passed.

REEB Millwork – attended the meeting and stated that they would be holding an open house and everyone in the Town was invited. Virginia expressed concerns for the need to purchase a new copier for the Town Office. REEB Millwork offered to buy the Town a copier.
